Researching Wills/Venue Change

The Principal Probate Registry was established on 12 January 1858, and keeps a copy of every will proved after 1858, as well as copies of letters of administration.

As well as the full name, address and occupation of the deceased, the **National Probate Calendar** may also contain:

- full names of executors, administrators and relationships to the deceased
- the date and place of the death
- the date and place of the probate or administration grant
- value of the estate

Members visiting the London Probate search facility which was at High Holborn are advised that this office has moved to Court 38, Royal Courts of Justice, Strand, London WC2A 2LL. The opening hours for searches of the probate calendars are between 9am to 1pm and 2pm to 4pm; search facility will be unavailable between the hours of 1-2pm. The fee payable for this service should be paid at the Fees Office, Royal Courts of Justice, which is signposted within the building.

The search facility will consist of the same search facilities as now and copies ordered for collection will be ready after **48 Hours**, if you have requested the postal option, and the copies will be posted within **14 working days.**

England & Wales, National Probate Calendar (Index of Wills and Administrations), 1858-1966

Members are advised that the date of the grant of probate may be many months after the date of the death.

The citations tell many stories of heroic deeds and dedication to duty and fellow combatants. Many of the entries are from the London Gazettes of the period and some from unit histories and other sources.
